

EMT (In-County) Between 12-24 Months of Expiration (date on EMT card)

EFFECTIVE June 19, 2014

In-County status refers to an EMT who lives in Kern County or is, at the time of re-certification, employed by a Kern County EMT provider.

As an EMT certifying authority, the Kern County EMS Division re-certifies individuals who possess a current EMT card issued by an EMS agency within California or the National Registry of EMTs. EMT re-certification may be done up to six months before expiration. Re-certification documentation may be mailed or brought in to our office.

Required Continuing Education (CE) hours and Skills Verification:

EMT Re-Certification (48 hours CE): In order to maintain EMT certification, an EMT shall possess a copy of expired EMT Certification issued in California, complete forty-eight (48) hours of CE from an approved continuing education provider, and successfully pass the National Registry test.

Skills Competency Verification: Required every two years, skills competency shall be verified by direct observation of an actual or simulated patient contact. Skills competency shall be verified by an individual who is currently certified or licensed as an EMT, AEMT, Paramedic, RN, PA, or physician and who are designated by an EMS approved training program (EMT training program, paramedic training program or continuing education provider) or an EMS service provider. EMS service providers include, but are not limited to, public safety agencies, private ambulance providers and other EMS providers.
