## Kroger Company Issues Voluntary Recall of Certain Frozen Berry Products Because of Possible Health Risks

Bakersfield, CA – Kroger Company has issued a voluntary recall of certain frozen berry products manufactured by Townsend Farms due to concerns over potential Hepatitis A contamination. Kroger operates grocery retail stores under many banners including: Kroger, Ralphs, Food 4 Less, and Foods Co. Kern County Environmental Health has been notified that product may have been distributed to stores in Kern County and is currently verifying that products are no longer being sold. "We encourage residents to check their freezers for these recalled products and discard them immediately," says Matt Constantine, Director of Kern County Public Health Services Department.

Hepatitis A is an infection that results from exposure to the Hepatitis A virus, including by eating contaminated food. It can range from a mild illness lasting a few weeks to a serious illness lasting several months. Illness generally occurs within 15 to 50 days of exposures and symptoms include fever, fatigue, loss of appetite, nausea, vomiting, abdominal pain, jaundice, joint pain, dark urine, and pale stool. Anyone with symptoms of Hepatitis A should contact their healthcare provider.

Hepatitis A can be prevented by vaccination. Check your immunization record to determine if you have received two doses of the Hepatitis A vaccination. If you have consumed the recalled product and have not received two doses of the Hepatitis vaccination, please contact your healthcare provider. Vaccination can prevent illness if given within two weeks of exposure to contaminated food.

There have been no locally reported illnesses associated with this recall.
