<u>Section 1</u>. This ordinance shall be published in accordance with Government Code section 25124 and it shall take effect and be in full force on and after the 23<sup>rd</sup> day of November, 2018.

<u>Section 2</u>. A new uncodified ordinance is added as set forth below in Sections 3 through 7.

<u>Section 3</u>. On and after November 23<sup>rd</sup>, 2018, the Emergency Medical Services initial and biennial certification and accreditation fees for prehospital personnel, pursuant to Kern County Ordinance Code Section 8.13.100, Chapter 8.13, Title 8 are as follows:

<u>Section 4</u>. On and after November 23<sup>rd</sup>, 2018, the Emergency Medical Services annual exclusive operating area ground ambulance operating permit fees and penalty fees for any act of non-compliance or breach within the exclusive operating area, pursuant to Kern County Ordinance Code Section 8.13.110 of Chapter 8.13, Title 8, are as follows:

Exclusive Operating Area	\$ 20,000
Non-Compliance Penalty Fee	\$ 1,000/zone/month
Breach Penalty Fee	\$ 5,000/zone/month

<u>Section 5</u>. On and after November 23<sup>rd</sup>, 2018, fees for extended services performed by the Emergency Medical Services program, pursuant to Kern County Ordinance Code Section 8.13.130 of Chapter 8.13, Title 8 is as follows:

Extended Service Fee	\$ 92/hour

<u>Section 6</u>. All fee categories listed above will be adjusted by the consumer price index for all urban consumers (CPI-U), all items, not seasonally adjusted, 1982-1984=100 reference base, effective July 1 of every year, commencing in 2019.

<u>Section 7</u>. The terms hereof are to be given the meanings stated in the codified portions of the Ordinance Code of the County of Kern.
