Proposed Report of Facility Information Amendment

The Kern County Public Works Department – owner/operator of the Ridgecrest Recycling & Sanitary Landfill – had submitted an application to amend the Report of Facility Information to address the LEA’s findings during its 5-Year Permit Review and other recent changes. Specifically, the Report of Facility Information has been amended to include:

1. Updates to waste Volumes, waste projections, and capacity information
2. Updates to Appendix A (Permits & Approval), Appendix E (Capacity Information)
3. Senate Bill 1383 operational information
4. Minor changes text incorporated

Updates to the Preliminary Closure/Post-closure Maintenance Plan include:

1. Minor changes to text incorporated
2. Updates to Appendix E (capacity information), Appendix R (closure and post-closure cost estimates), Appendix T (non-water release cost estimate)

LEA Determination

Kern County Environmental Health Division, acting as the Local Enforcement Agency (LEA), has approved the Report of Facility Information Amendment. The LEA has also determined that the RFI Amendments do not require modification or revision to the Solid Waste Facility Permit. The LEA accepted the application on September 21, 2021
