AMBULANCE COMPLIANCE FINES	
NON-COMPLIANCE- occurs when an ambulance provider fails to meet the 90% response time standard within a response time zone, within an EOA, in any month up to 3 consecutive months	\$1000
BREACH- of Contract occurs when an ambulance provider fails to meet the 90% response time standard within a response time zone, within an EOA, in a 4 th consecutive month.	\$5000
