
AN UNCODIFIED ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF KERN, STATE OF CALIFORNIA, ESTABLISHING THE EMERGENCY MEDICAL SERVICES CERTIFICATION AND ACCREDITATION, EXCLUSIVE OPERATING AREA GROUND AMBULANCE OPERATING PERMIT AND PENALTY, AND EXTENDED SERVICE FEES PURSUANT TO KERN COUNTY ORDINANCE CODE SECTIONS 8.13.020, 8.13.100, 8.13.110, AND 8.13.130

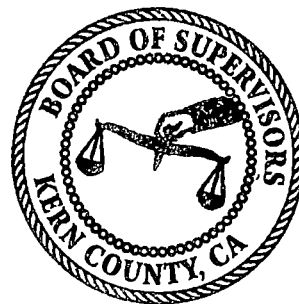




THE BOARD OF SUPERVISORS OF THE COUNTY OF KERN ORDAINS AS FOLLOWS:

Section 1. This ordinance shall be published in accordance with Government Code section 25124 and it shall take effect and be in full force on and after the 23rd day of November, 2018.

Section 2. A new uncodified ordinance is added as set forth below in Sections 3 through 7.

Section 3. On and after November 23rd, 2018, the Emergency Medical Services initial and biennial certification and accreditation fees for prehospital personnel, pursuant to Kern County Ordinance Code Section 8.13.100, Chapter 8.13, Title 8 are as follows:

Certification	\$ 100
Accreditation	\$ 100

Section 4. On and after November 23rd, 2018, the Emergency Medical Services annual exclusive operating area ground ambulance operating permit fees and penalty fees for any act of non-compliance or breach within the exclusive operating area, pursuant to Kern County Ordinance Code Section 8.13.110 of Chapter 8.13, Title 8, are as follows:

Exclusive Operating Area	\$ 20,000
Non-Compliance Penalty Fee	\$ 1,000/zone/month
Breach Penalty Fee	\$ 5,000/zone/month

Section 5. On and after November 23rd, 2018, fees for extended services performed by the Emergency Medical Services program, pursuant to Kern County Ordinance Code Section 8.13.130 of Chapter 8.13, Title 8 is as follows:

Extended Service Fee	\$ 92/hour
----------------------	------------

Section 6. All fee categories listed above will be adjusted by the consumer price index for all urban consumers (CPI-U), all items, not seasonally adjusted, 1982-1984=100 reference base, effective July 1 of every year, commencing in 2019.

Section 7. The terms hereof are to be given the meanings stated in the codified portions of the Ordinance Code of the County of Kern.
